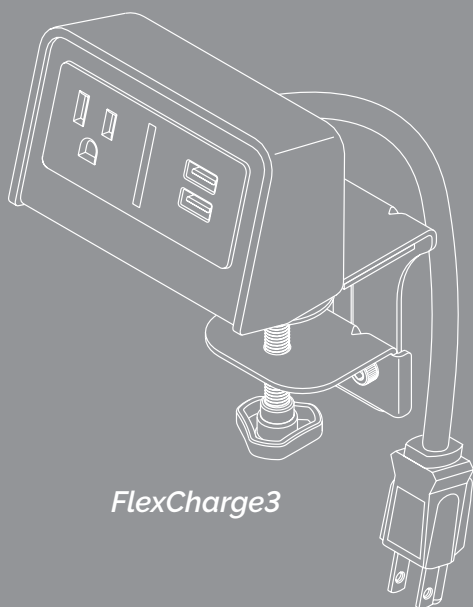


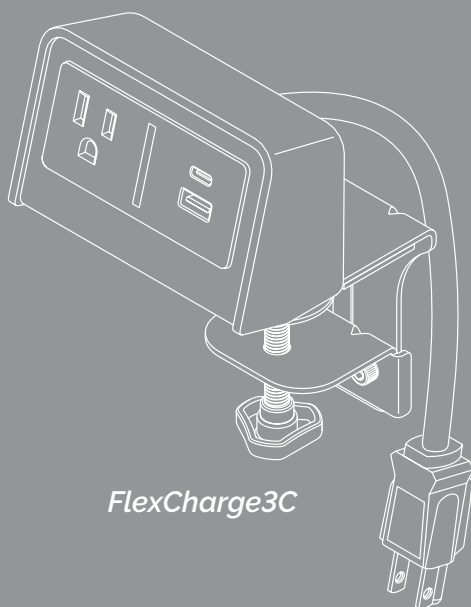

## **Safety instructions and warnings**

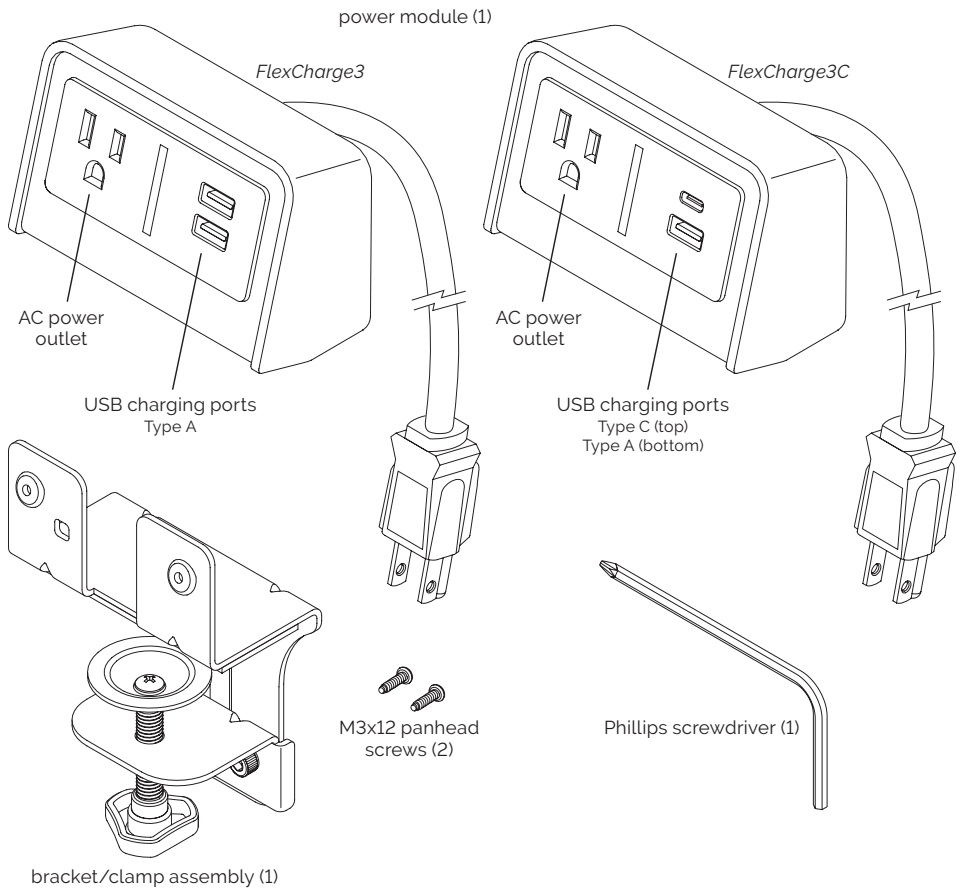
Always read safety instructions carefully.

- Do not install near heat sources such as radiators, heat registers, stoves or other equipment (including amplifiers) that produce heat.

- DO NOT USE this unit in the presence of a flammable anesthetic mixture with air, oxygen or nitrous oxide.

**Please review** these instructions before beginning the installation. Check that all parts and tools needed were provided with your order (see illustration below).. Contact your supplier if any parts are missing. Do not discard the packaging until the product works to your satisfaction.

Note that the only difference between models 3 and 3C is the USB port configuration on the power module. **FlexCharge3** has two Type-A USB ports, while **FlexCharge3C** has one Type-A port and one Type-C port.

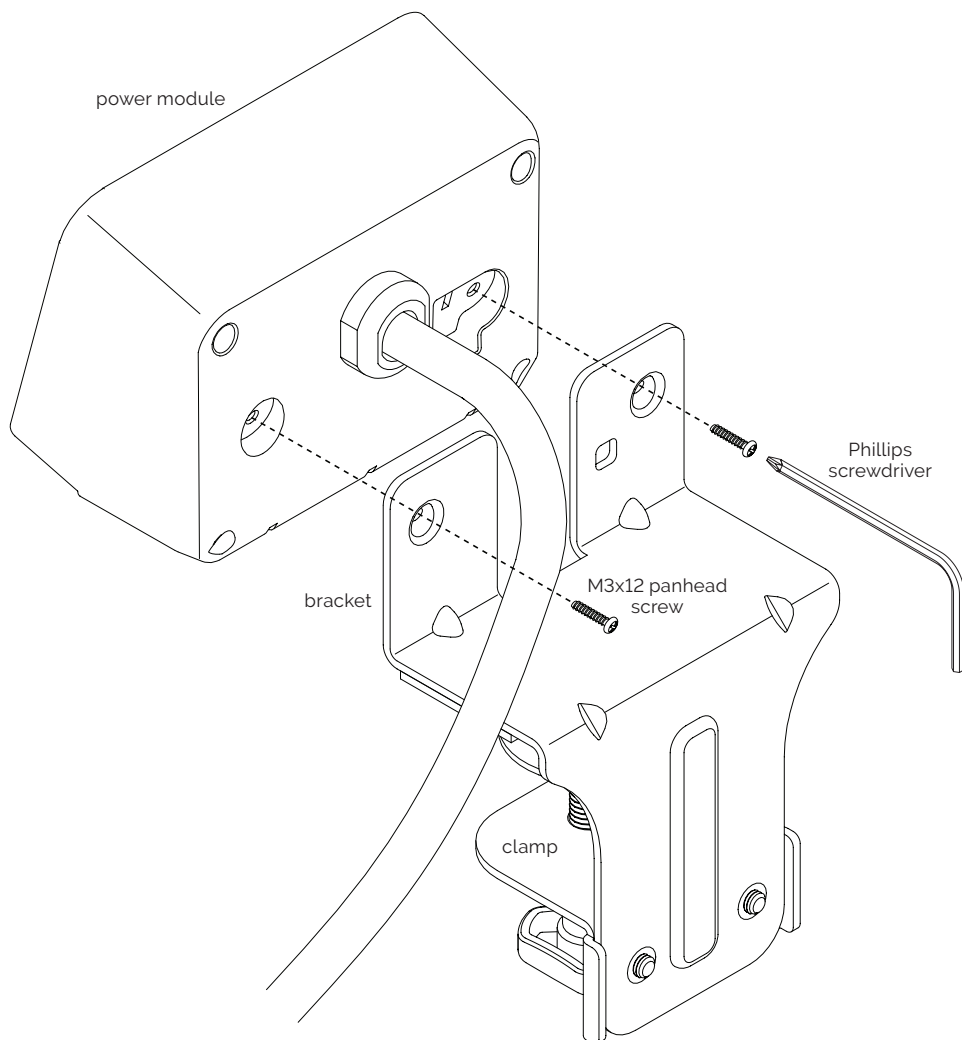
**Components and tools**



**Important:** hand-tighten screws only.

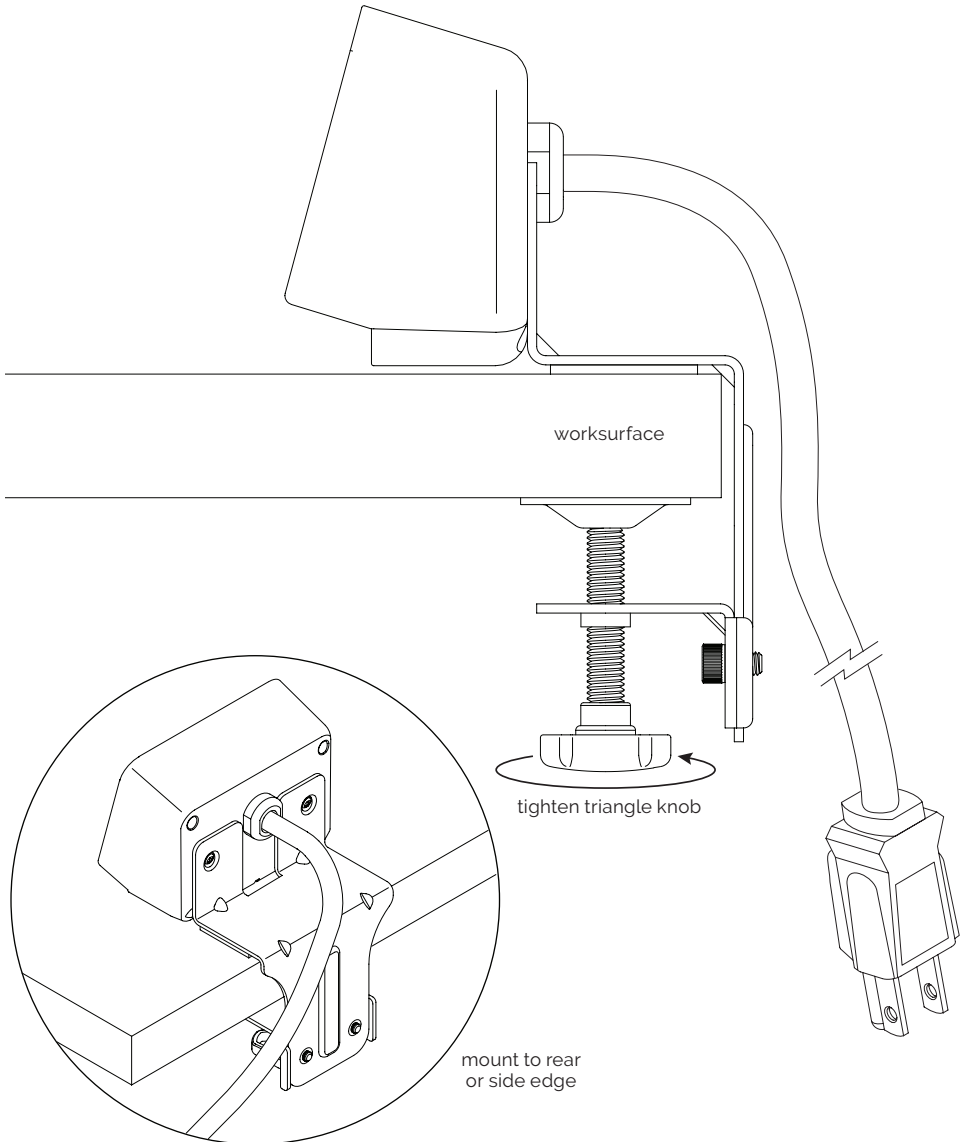
**Step #1: attach bracket/clamp assembly to power module**

- Route the power cord through the opening in the top bracket.
- Attach the top bracket to the rear of the power module using the two M3x12 panhead screws.
- Tighten securely using the provided Phillips screwdriver.



**Step #2: clamp assembled FlexCharge unit to worksurface**

- Position the FlexCharge unit in the desired location on the rear edge or side edge of the worksurface.
- Clamp the unit securely in place by tightening the triangle knob.
- Plug the power cord into an AC outlet.

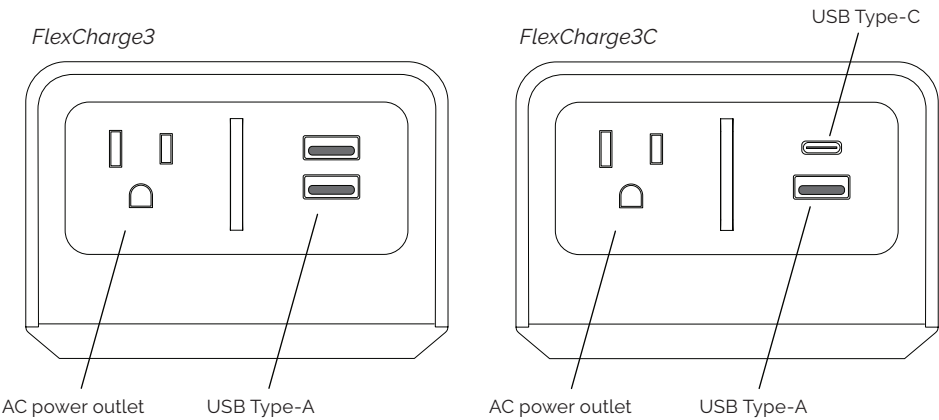
